Location...

The site is located approximately 4 miles to the south-west of Boston, which is a bustling market town approximately 150 miles to the north of London, 35 miles to the south-east of Lincoln, 40 miles to the east of Nottingham and 35 miles to the west of King's Lynn.

The property is approximately ½ mile from the A17 trunk road which connects East Anglia to the East Midlands, also close to the A16 trunk road to Peterborough and London and the A52 trunk road to Nottingham.

Nearby properties include residential housing and rural agricultural land.

Fenhouses is a hamlet located approximately 1 mile to the east of Swineshead to the north of the B1391, connecting Swineshead to Wyberton, a suburb to the south of Boston.

Accommodation...

A gated entrance leads to the main yard being part concrete part surfaced having a secure perimeter wall.

Workshop.....17.4m x 11.6m, 202sqm
Having a minimum internal eaves height of 3.2m, high impact concrete floor, insulated walls.

Tenure...

The building is available by way of a new Full Repairing and Insuring lease with a minimum term of 3 years.

The tenant will be responsible for the landlord's legal fees up to a maximum of £750 with regards to the preparation of the lease.
