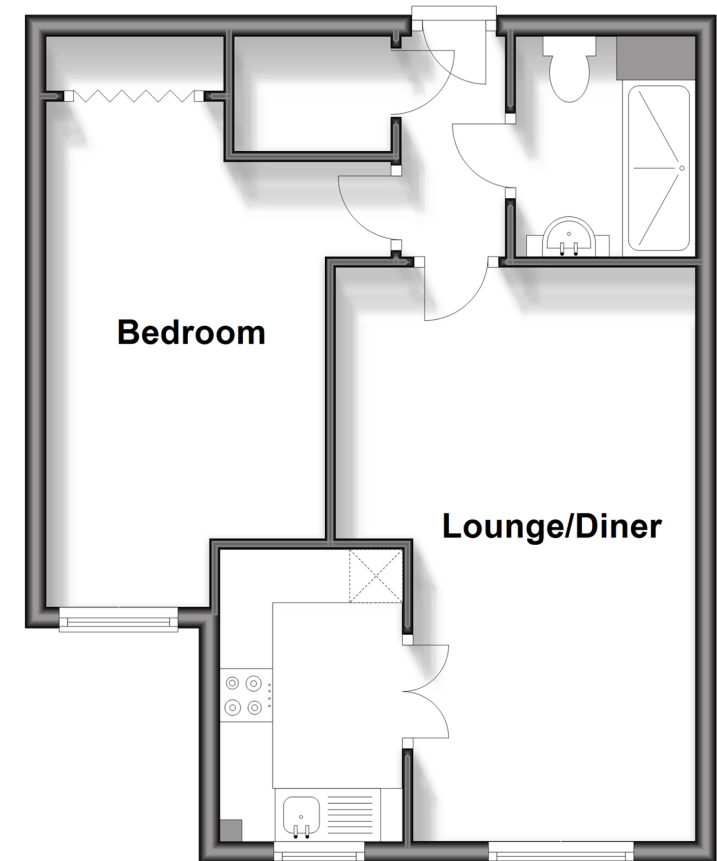

Auctioneer's Comments
