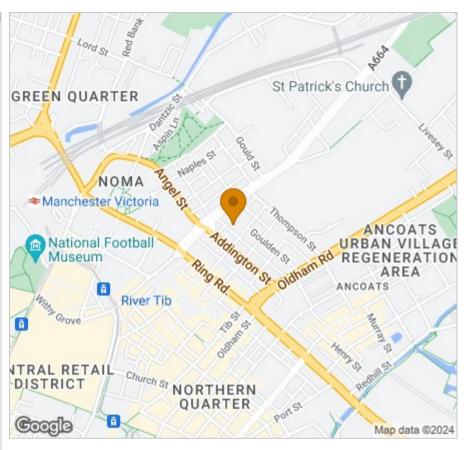

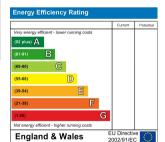

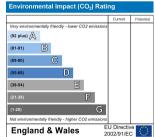
Floor Plan Area Map
