Outside there is a single garage en-bloc. The rear garden is mainly laid to lawn with a patio area, and is enclosed by fencing.

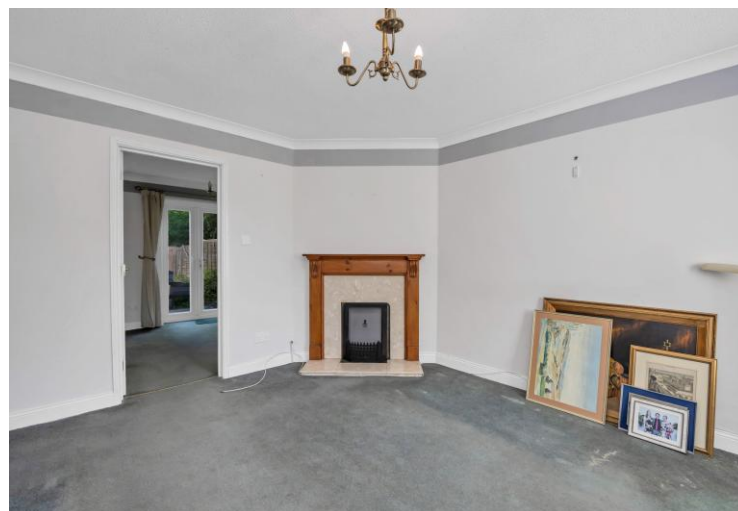

Heading along Bedingfield Road, turn left at the John Banks roundabout onto Orttwell Road, at the next roundabout turn right onto Cranesbill Drive and first left on to Bluebell Avenue where the property can be found on your left.

The historic market town of Bury St Edmunds provides an extensive range of shopping facilities, including the Arc Shopping Centre. There are also excellent educational, recreational and cultural facilities and for those needing to commute there is convenient access to the A14, which provides links to Cambridge, Ipswich and London / Stansted Airport via the A11/M11. The railway station at Bury St Edmunds offers a link to mainline services to London Liverpool Street and Kings Cross.

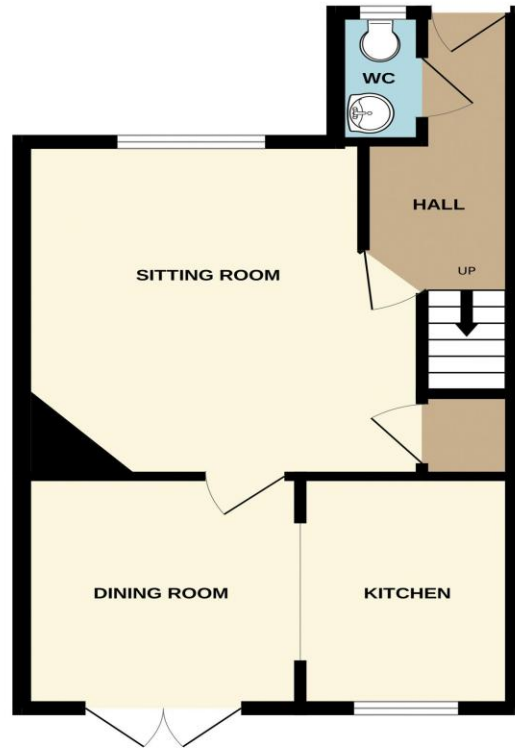

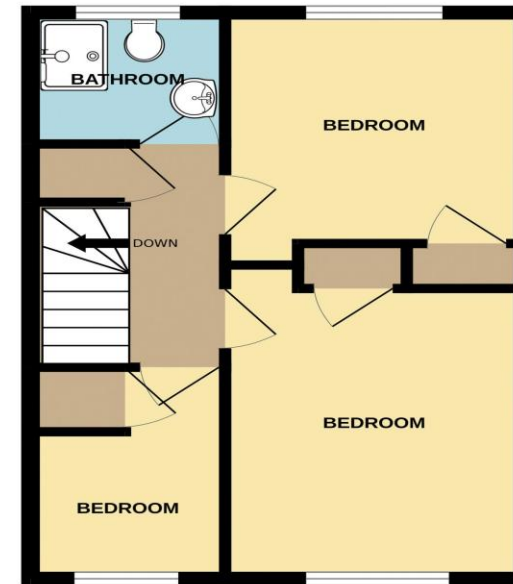
