Leaving Bury St Edmunds town centre via Eastgate Street, at the roundabout turn right on Barton Road. Take the second right into Kingsworth Road and then a left onto Pond Grove Close, then a right onto Brackenwood crescent. Follow the road round and the property will be found at the end of the road.

Location

The historic market town of Bury St Edmunds provides an extensive range of shopping facilities, including the Arc Shopping Centre. There are also excellent educational, recreational and cultural facilities and for those needing to commute there is convenient access to the A14, which provides links to Cambridge, Ipswich and London / Stansted Airport via the A11/M11. The railway station at Bury St Edmunds offers a link to mainline services to London Liverpool Street and Kings Cross.

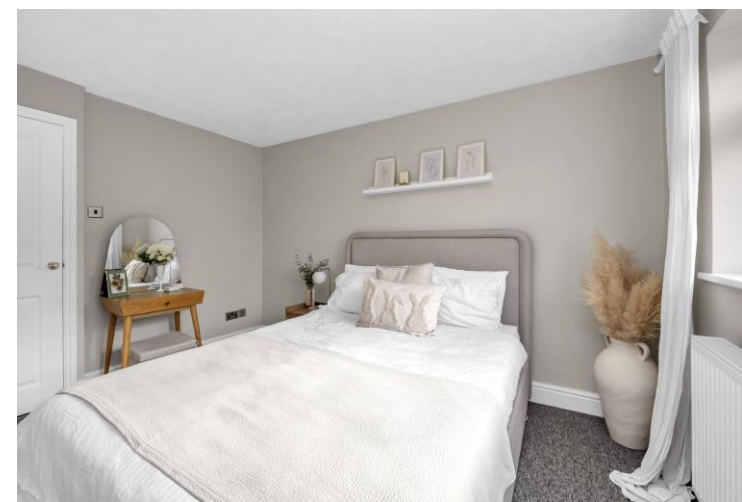

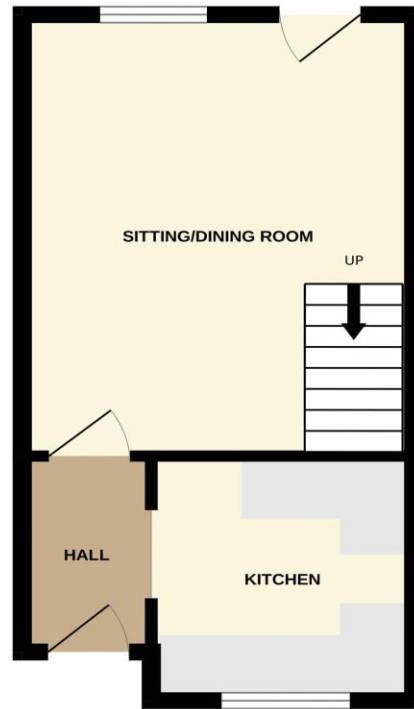

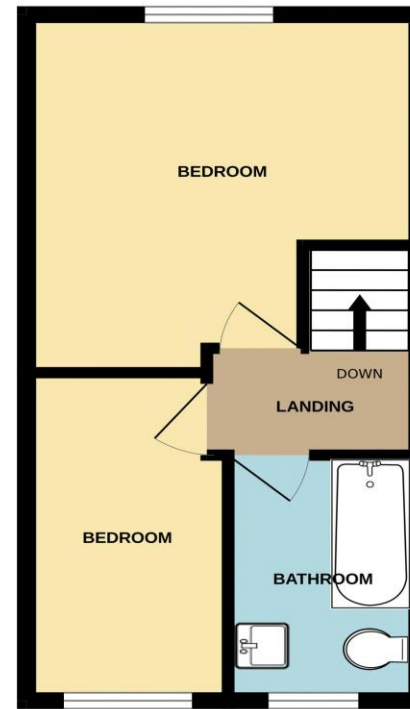
