On the first floor, there are four bedrooms, the principal benefits from an ensuite shower room and built-in wardrobes with bedroom two also benefitting from an ensuite.

Outside, parking is offered via a driveway. To the rear, there is an enclosed garden mainly laid to lawn with a paved patio area, garden shed and outside studio, ideal as a work from home space or garden room.

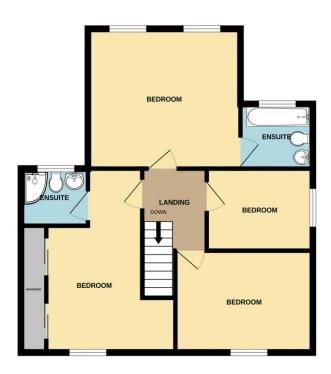
