A two-bedroom, terraced property offering accommodation on the ground floor to include an entrance porch, sitting room, kitchen/dining room and a conservatory leading to the garden. On the first floor, there are two bedrooms, the second bedroom benefits from built-in wardrobes and the bathroom completes the accommodation on offer.

Outside, the front garden is laid to shingle with a path leading to the front door and hosts a variety of flowers and shrubs. The rear garden is laid to lawn with a paved patio area and planted border. Parking is offered via a driveway at the end of the terrace.

Proceed out of Bury via Fornham Road, at the traffic lights turn left onto Tollgate Lane and take the right hand turning onto Lancaster Avenue and immediate left on to Northumberland Avenue. Follow this road until you see a left hand turning into St Olaves Road and at the roundabout go straight over and then turn right into Oakes Road, take the second turning on the right into Anderson Walk and the property can be found.

Location

The historic market town of Bury St Edmunds provides an extensive range of shopping facilities, including the Arc Shopping Centre. There are also excellent educational, recreational and cultural facilities and for those needing to commute there is convenient access to the A14, which provides links to Cambridge, Ipswich and London / Stansted Airport via the A11/M11. The railway station at Bury St Edmunds offers a link to mainline services to London Liverpool Street and Kings Cross.

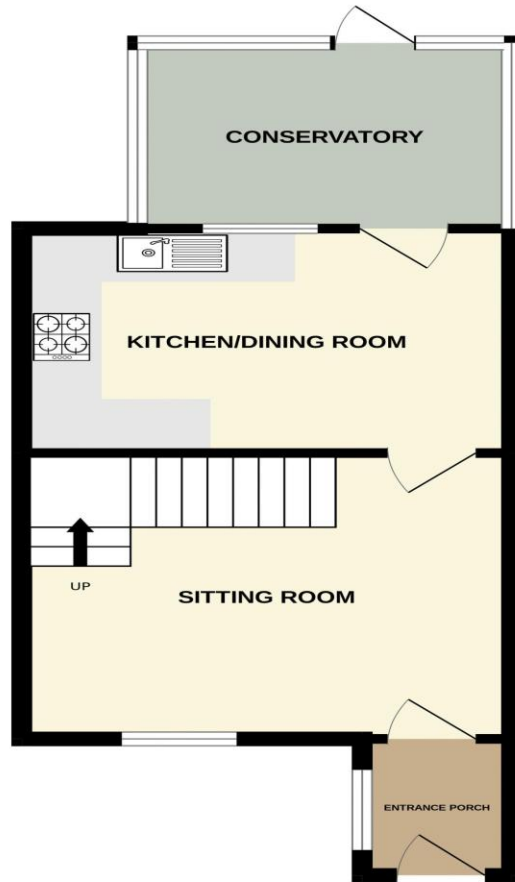

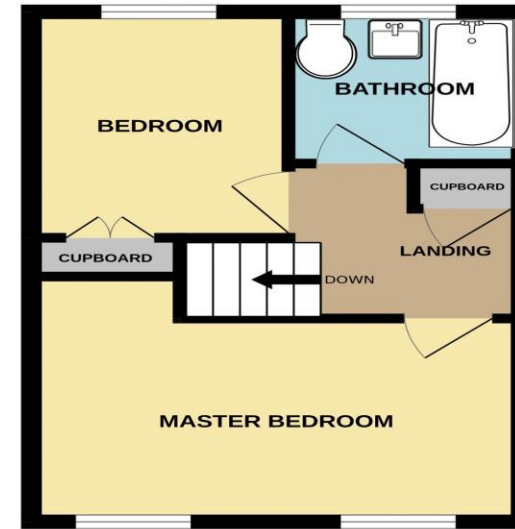
