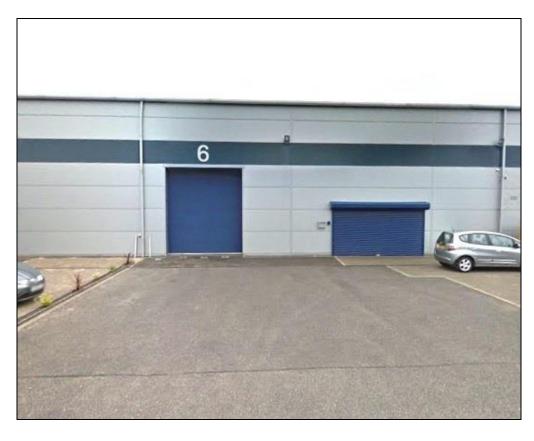

Nechells Parkway connects to the Middle Ring Road giving access to Birmingham City Centre approximately 1.5 miles distant and easy access to Junction 6 of the M6 Motorway approximately 1.5 miles distant.

#### **Description:**

The property is a modern mid-terrace industrial unit of steel portal frame construction with a steel profile clad roof incorporating roof lights with block work and steel profile clad elevations and a concrete floor.

Externally, the property benefits from a tarmac service yard and car parking area.

The estate also provides CCTV and automated estate gates for out of hours security.
