LOCATION

The property is in Stafford Park in Telford, an established industrial and distribution estate accessed off Junctions 4 and 5 of the M54 motorway. Telford has a wide and diverse manufacturing employment base with major manufacturers including Denso, Epson, Epwin, Makita, Magna International, Ricoh UK, and BAE Systems.

Telford is home to The Ministry of Defence Fulfilment Centre and other warehouse operators including DHL, UPS, Maidens of Telford (Kinaxia Logistics), and Simmonds Transport. Telford is 15 miles east of Shrewsbury, 15 miles to Junction 10a of the M6, 17 miles north west of Wolverhampton and 22 miles north west of Birmingham. Telford Central Railway Station is located 0.9 miles (20 minutes walk) to the East.

Direct access to J4 and J5 of the M54, 32 miles northwest of Birmingham.





DESCRIPTION

The property comprises a detached industrial warehouse unit of steel portal frame construction under a profiled steel-clad roof and translucent panels. Ground floor office and ancillary accommodation is provided. The unit will be refurbished to a high quality. Consideration will be given to letting the property in two parts from approximately 51,645 sq ft.
