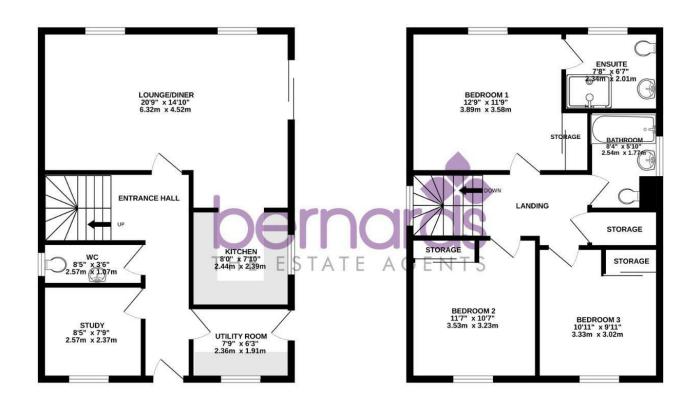
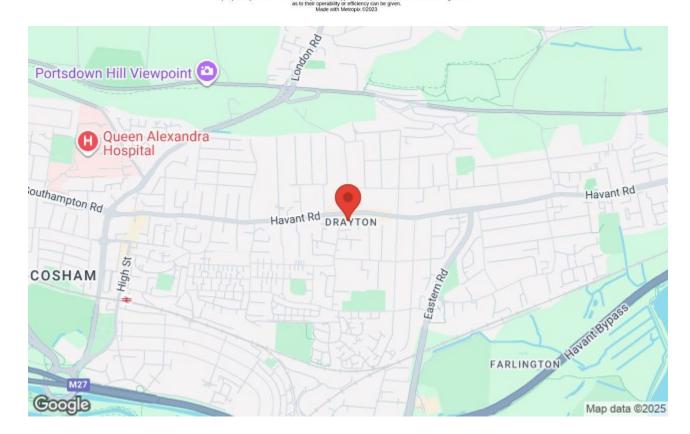

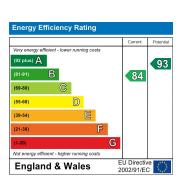

TENANT FEES ACT 2019

As well as paying the rent, you may also be required to make the following permitted payments.

Tenant Fees Act 2019 means payments:

· Holding deposits (a maximum



of 1 week's rent);

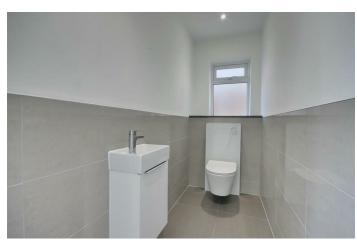
- · Deposits (a maximum deposit of 5 weeks' rent for annual rent below £50,000, or 6 weeks' rent for annual rental of £50,000 and above);
- · Payments to change a tenancy agreement eg. change of sharer (capped at £50 or, if higher, any reasonable costs);
- · Payments associated with early termination of a tenancy (capped at the landlord's loss or the agent's reasonably incurred costs);
- · Where required, utilities (electricity, gas or other fuel, water, sewerage), communication services (telephone, internet, cable/satellite television), TV
- · Council tax (payable to the billing authority);
- · Interest payments for the late payment of rent (up to 3% above Bank of England's annual percentage rate);
- Reasonable costs for replacement of lost keys or other security devices;
- Contractual damages in the event of the tenant's default of a
