### LOCATION

The land is situated to the south of Westham, village, approximately 3.8 miles to the north-east of Eastbourne.



### DESCRIPTION

The property comprises a parcel of marsh grazing land, divided into three enclosures by ditches. The area forms part of the south Pevensey Marshes, renowned for their abundance of wildlife and flora, and excellent grazing qualities.

According to the Agricultural Land Classifications Provisional Maps for England, the land is Grade 3.
