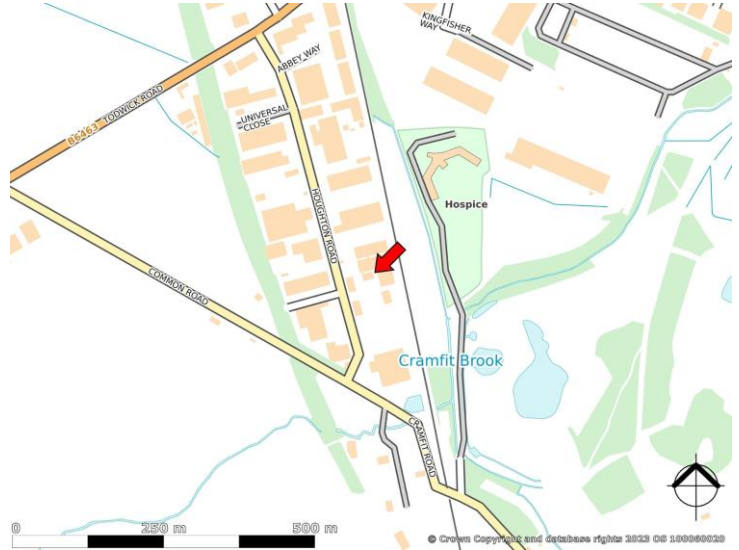


Light industrial unit with 7 domestic parking spaces.
