
Offered on a 70% shared ownership basis, with the option to staircase to 100%, this stylish home is perfect for first-time buyers or professionals seeking convenience and modern living.


With excellent transport links, local amenities, and green spaces nearby, this apartment provides the perfect blend of comfort and convenience.

Trumpington Meadows nature reserve links Trumpington through to Byron's Pool and Grantchester and there is a second country park between Trumpington and the Addenbrooke's campus. Various bridleways and footpaths lead immediately out into the countryside towards Harston, Haslingfield, Barton and Grantchester.
