There is a separate utility room with space and plumbing for a washing. Easy access to M4/M25/M40/A40/London Heathrow and 0.5 miles (11 minute walk) from Langley railway and Elizabeth Line station. 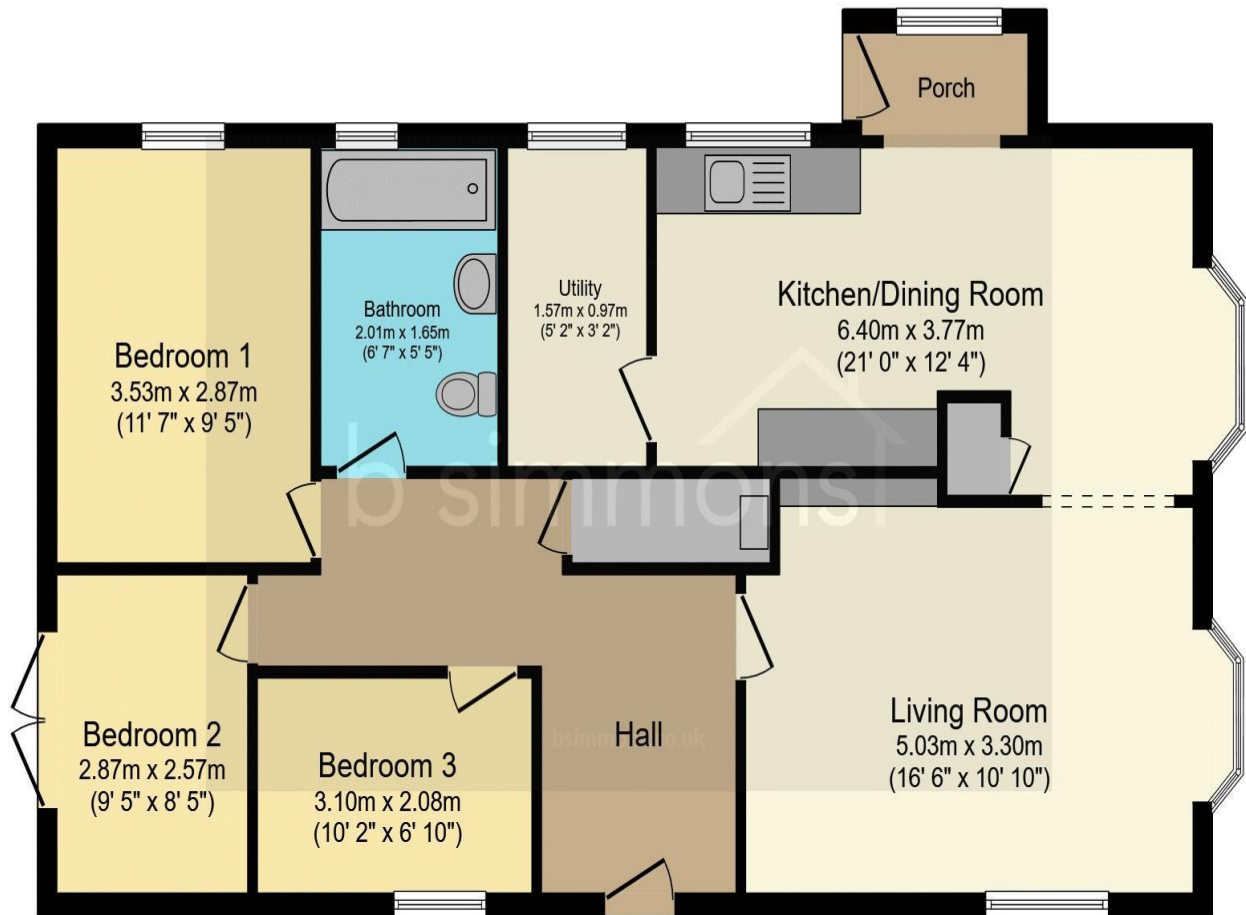
