The current owner is selling the property with NO ONWARD CHAIN. Tucked away in this private cul-de-sac development, this detached family home is set over three floors. As you enter through the front door, you immediately walk into an inviting hallway with stairs leading to the first floor with built in understairs storage. Adjoining doors follow through to; a downstairs W.C, a living room with a feature fireplace [and door out to the rear garden], a separate bay fronted dual aspect dining room and a modern fitted kitchen/breakfast room measuring approximately 31', with integrated appliances and French doors leading out to the rear garden. On the first floor, there are three double bedrooms, all having built in wardrobes and the master having an en-suite. There is a fourth single bedroom and a separate family bathroom having a four piece suite. On the top floor of this home there is a large double bedroom with built in wardrobes and another en-suite. Outside to the rear of the property, there is a private rear garden, predominantly laid to lawn with mature shrub borders, a patio area for outside entertaining and a gate giving side access. At the front of the property, there is a block paved driveway providing ample parking as well as a single garage with an additional parking space to the front.

Oak View Gardens is one of Langley's most premium cul-de-sacs, located within the Castlevue area, just a short walking distance to Langley's most sought-after primary, secondary and grammar schools. Upton Court and Kedermister Parks are just a stones-throw away.
