Norwood Road offers a host of bars, shops and amenities including the new Picture House Cinema, health centre and library.

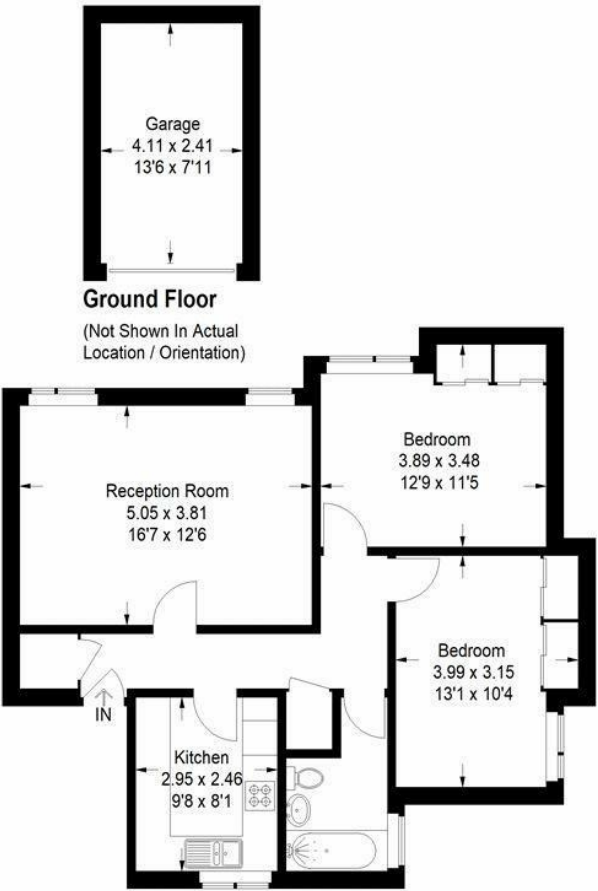

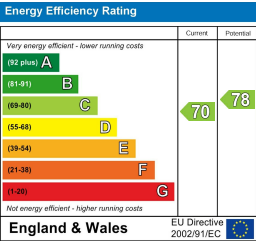
# Floorplan
