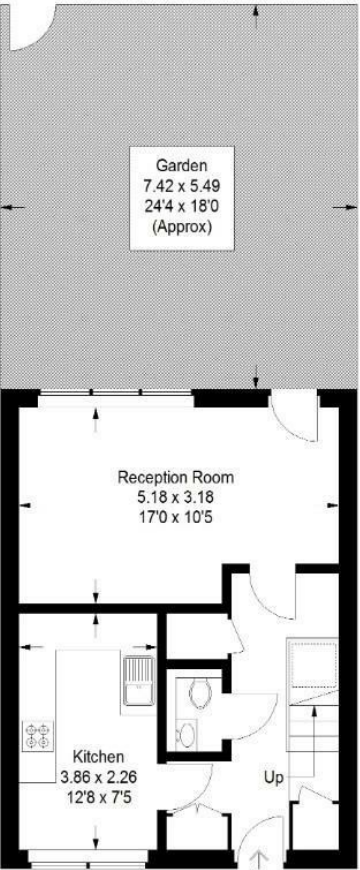

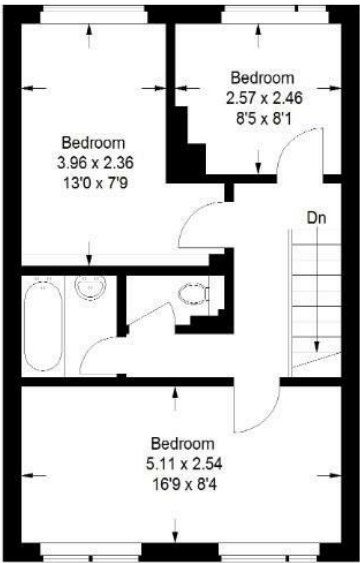

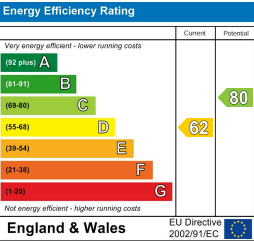
Ground Floor
