Tenancies are issued to individual staff members and all tenants have access to shared communal facilities.

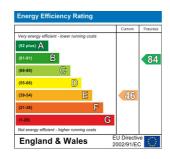

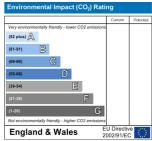
