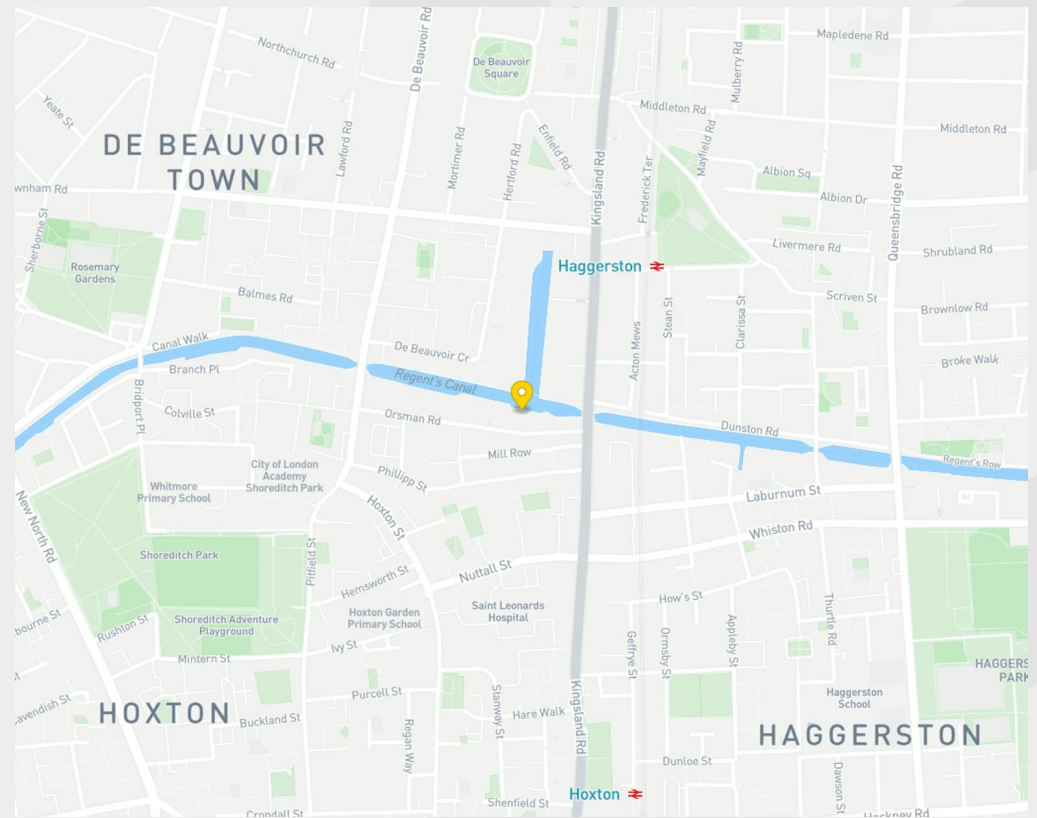


Description

A fully fitted ground floor restaurant / cafe premises with a private partially covered terrace of circa 400 sq.ft directly facing the Regents Canal. The main section of the space has a larger fitted bar / servery, together with customer WC facilities. The unit would ideally suit a range of restaurant, coffee, bakery / deli operators, for use as an events space or for food production - subject to necessary consents.

Location

Located on the north side of Orsman Road approximately 100 metres from the junction with Kingsland Road. This is a location that supports a wider variety of creative and office occupiers, as well as a strong residential neighbourhood. Haggerston Overground station is within a short walk and is access to numerous bus routes which run along Kingsland Road. The building benefits from being situated directly adjacent to the Regents Canal.
