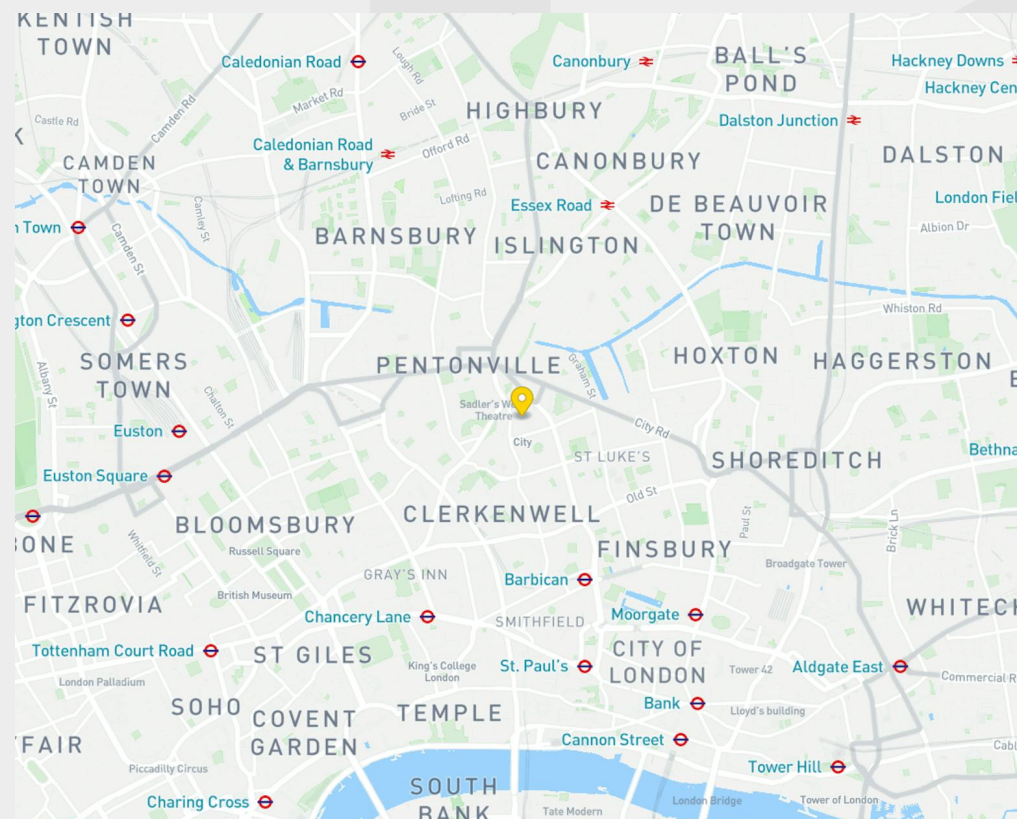


Description
