



Proceed over the first mini roundabout onto Bridge Street and left at the double mini roundabouts onto West End. Follow this road along to the mini roundabout, turning right onto Hailey Road. Take the first turning on the right into Farmers Close, and right again into the first close. Bakers Piece is found after a short distance on the right hand side. 07E24
