This presents a unique opportunity for those wishing to become part of this vibrant village community while enjoying the beauty of the surrounding Peak District landscape.

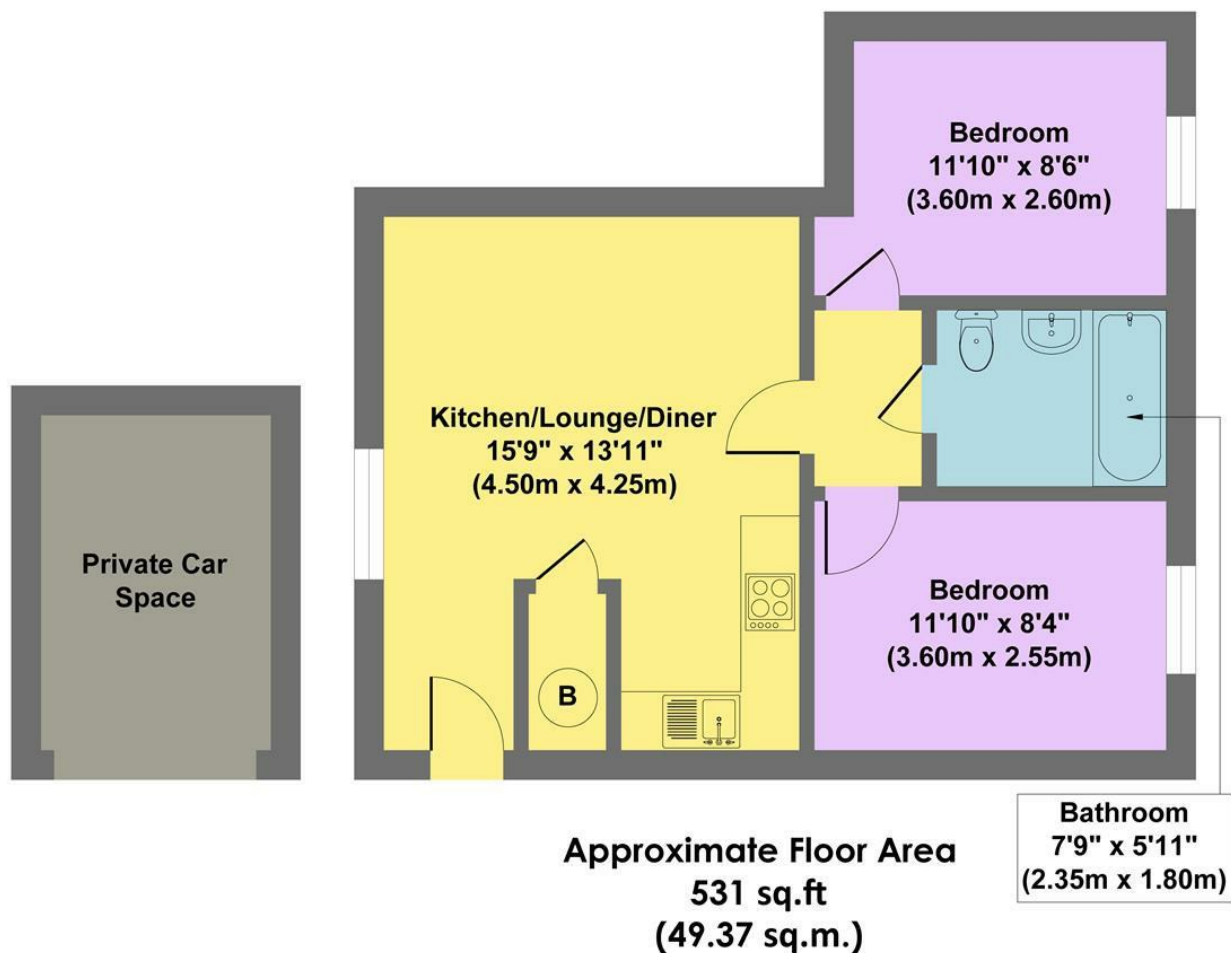
