

TENANT FEES Tenant Fees Act 2019

As well as paying the rent, you · the following permitted payments.

For properties in England, the Tenant Fees Act 2019 means that in addition to rent, lettings agents can only charge tenants (or anyone acting on the tenant's behalf) the following permitted payments:

- · Holding deposits (a maximum of 1 week's rent);
- Deposits (a maximum deposit of 5 weeks' rent for annual rent below £50,000, or 6 weeks' rent for annual rental of £50,000 and above); LIVING ROOM
- tenancy agreement eg. change of sharer (capped at DINING ROOM £50 or, if higher, any 10'3" x 8'10" (3.147 x 2.708) reasonable costs);
- Payments associated with KITCHEN early termination of a tenancy (capped at the landlord's loss UTILITY ROOM or the agent's reasonably 9'7" x 6'1" (2.936 x 1.860) incurred costs);
- · Where required, utilities BATHROOM (electricity, gas or other fuel, 7'10" x 5'6" (2.392 x 1.681) water, sewerage), communication services (telephone, internet, cable/satellite television), TV licence;
- · Council tax (payable to the billing authority);
- · Interest payments for the late payment of rent (up to 3% above Bank of England's annual percentage rate);
- · Reasonable costs for replacement of lost keys or other security devices;



Any other permitted may also be required to make payments under the Tenant Fees Act 2019 and regulations applicable at the relevant

RIGHT TO RENT

Each applicant will be subject to the right to rent checks. This is a government requirement since February 2016. We are required to check and take a copy of the original version of acceptable documentation in order to adhere to the Right to rent checks. This will be carried out at referencing stage. 
