
6 Elworthy Drive is a spacious 4 bedroom detached family home of traditional cavity construction with a brick outer leaf, a tile hung front and rear elevation and a tiled roof situated in a sought after location on the South side of Wellington and within walking distance of the town centre. The property benefits from uPVC double glazing, gas fired central heating and is offered to the market with NO ONWARD CHAIN.

The accommodation is arranged over two floors and briefly comprises an entrance hall with downstairs cloakroom and doors to the principal rooms. The sitting/dining room is a generous size with ample space for furnishings, a picture window to the front elevation enjoying far reaching views to the Blackdown Hills and Wellington Monument and sliding patio doors to the rear garden.

The kitchen/breakfast room is fitted with a range of wall and base units with space for appliances, room for a table and chairs and a door to the garden.
