




**E332'000 Ereehold W89 12AT** Wellington, 41 Mills Drive







LOCATION: The property sits to one side of this modern development ideally placed on the outskirts of Wellington, yet still within walking distance of the town centre. Wellington offers a wide range of independently run shops and larger national stores including the well renowned Waitrose. The town itself stands between the River Tone and the Blackdown Hills. The County Town of Taunton is approximately 8 miles distant with its mainline railway station and the M5 can be accessed via Junction 26 just outside the town.

DIRECTIONS: From our town centre office proceed in the Taunton direction passing through the traffic lights, as you leave the town centre, take the second exit at the first roundabout and third exit at the second roundabout into the Cades Farm development. 



41 Mills Drive is a four bedroom link detached property situated on the popular Cades Farm development within easy reach of local amenities and transport links.

The property comprises in brief; a sitting room with French doors to the rear garden and the kitchen/dining room benefitting from plenty of wall and base units for storage, a stainless-steel sink and an integrated double oven with a four ring gas hob and extractor above. There is plenty of space for white goods and dining furniture and there are also doors to the rear garden. Completing the downstairs accommodation is the downstairs cloakroom, airing cupboard and under stairs storage cupboard.

The first floor offers four bedrooms with the master benefiting from an ensuite. The remaining bedrooms are serviced by the family bathroom with a white suite and hand held shower over the bath.
