A delightful three bedroom mid terrace character red brick home situated in a popular residential street within walking distance of Wellington town centre. The property is now offered to the market with NO ONWARD CHAIN.

The accommodation comprises in brief; front door opens into the entrance hallway with stairs rising to the first floor and doors to the principal rooms.

The sitting room lies to the front of the property with a bay window and open fireplace, whilst sitting centrally is a second reception room, currently used as a dining area, with ample space for furnishings, an under stairs storage cupboard and open fireplace.

To the rear of the property, the kitchen is fitted with a comprehensive range of wall and base units with space for a cooker, washing machine and fridge/freezer with a door to the rear garden.
