

Occupants must be 60 years of age or over and have obtained the Estate Manager's approval for residency. The Service Charge is £3,836.05 2025-2026 and includes the pull-cord emergency-alert system, Estate Manager services, management fee, window cleaning, maintenance and insurance of the buildings and gardens. Upon re-sale of the property the vendor is liable to pay back into the sinking fund a contribution calculated at 1.5% per annum of the original purchase price for the years owned. 
