LOCATION: Wellington is a friendly Somerset town set in a wide valley near the scenic Blackdown Hills just 7 miles from Taunton, and easily accessible via junction 26 of the M5. Many visitors and travellers pass the spotlit Wellington monument on the top of the hill overlooking the town which was built to celebrate the Duke of Wellington's victory at the battle of Waterloo. The high street boasts several independent shops and cafes, five pubs, and the town has also recently become a 'Food Town' and hosts various events and initiatives to celebrate the best in local food and drink. Whilst the 'Wellesley', the town's unique 1930s cinema offers entertainment in the evening. Of course there is a choice of supermarkets in the centre including a Waitrose where you can take care of your weekly shop. For families with children, Wellington and its surrounding area offer a choice of Ofsted-rated 'Good' schools and excellent private schools. The Bridgwater and Taunton College with its dual-site campus, (the nearest being Taunton) offers some excellent further education options.
