

A beautifully presented two bedroom attached bungalow situated in a sought after location on the south side of Wellington within walking distance of the town centre and with easy access to the A38 and the M5 at Junction 26.

The accommodation comprises in brief; front door opens into the entrance porch with a further door into the entrance hallway with a useful built in cupboard and access to the principal rooms. The kitchen is fitted with a range of wall and base units with contrasting work surfaces, an integrated oven and hob and space for further appliances. The sitting/dining room is open plan in concept with ample room for all everyday furnishings with patio doors leading out to the garden, creating the ideal entertaining area.

There are two bedrooms serviced by the shower room which features a modern double walk in shower suite with low level WC, vanity sink and heated towel rail.
