GROUND FLOOR

ENTRANCE HALL: UPVC Double glazed entrance door. Stairs to first floor.

LOUNGE: 3.35m x 2.77m (11' plus recess x 9'11" max) UPVC Double glazed window to front. Radiator. Fire.

OUTSIDE


FRONT: Driveway providing off road parking.
