BEDROOM TWO: 3.42m x 2.74m (11'03" x 9') Double glazed window to rear. Radiator.

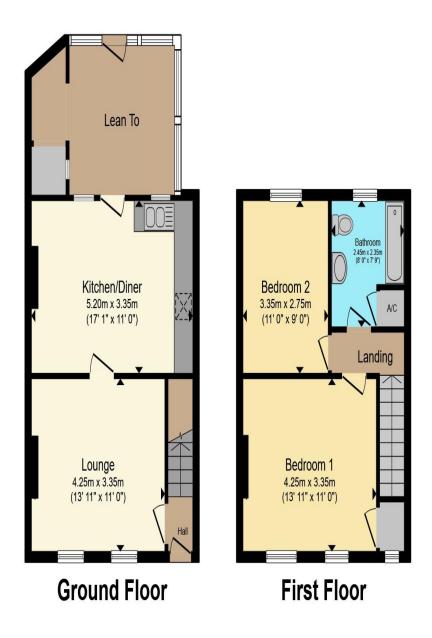
BATHROOM: Double glazed window to rear. Low level WC. Wash hand basin with mixer tap. Bath with mixer tap and mains shower over.
