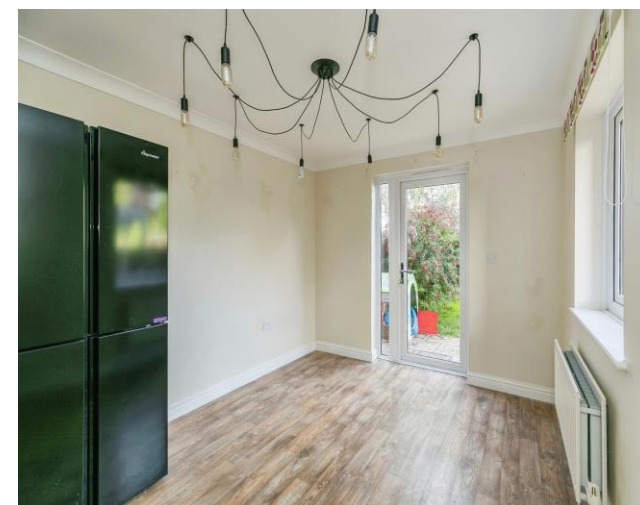

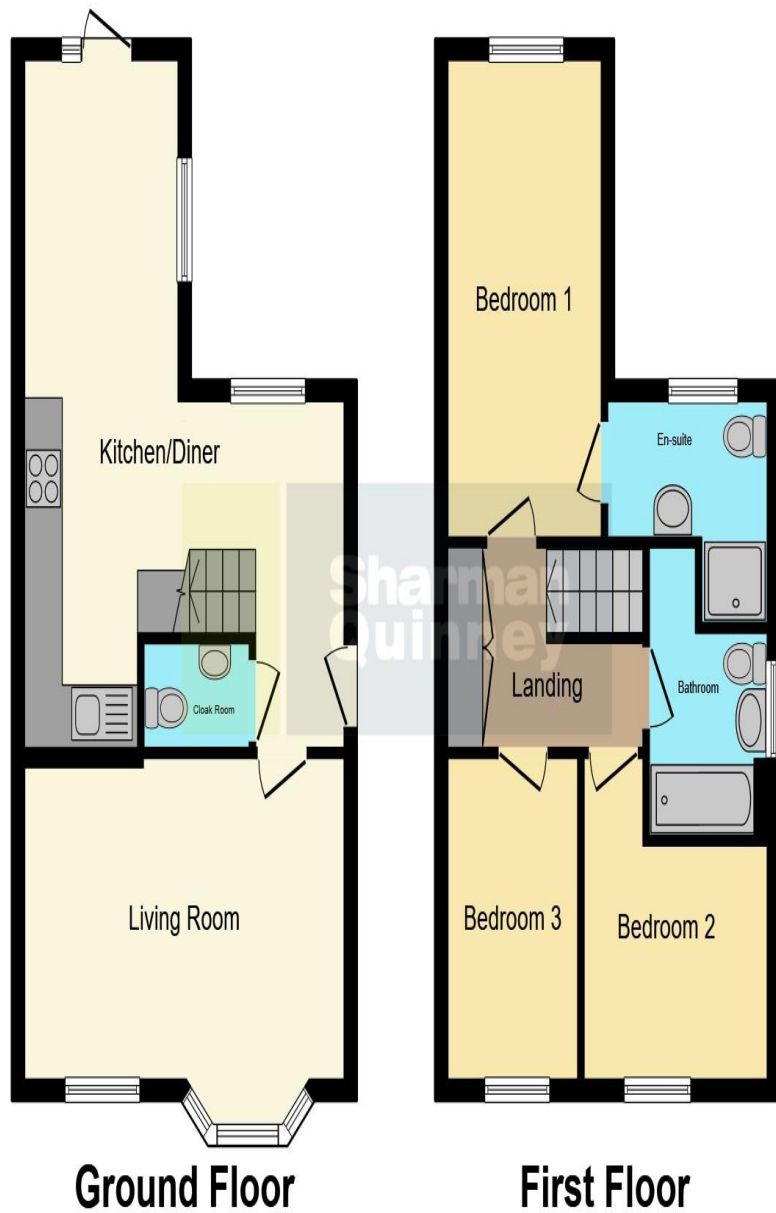


Bathroom
