
Entrance hall - 6.2m x 1.3m (20'3" x 4'2")

Composite front door. tiled flooring. leads to bedrooms, bathroom, and kitchen/diner/lounge to rear. Loft access via built in ladder. The loft has a velux window and is fully boarded

Lounge - 5.1m x 4.4m (16'7" x 14'4") Laminate flooring with underfloor heating. bifolding doors opening into garden. Lounge is open concept kitchen/diner but can be closed off with sliding doors.

Kitchen/Diner - 7.3m x 4.4m (23'9" x 14'4") being L Shaped

Tiled floor. Range of wall and base units with gloss doors and wood effect work tops. Stainless steel sink. Integrated oven and hob, fridge/freezer and







space for washing machine/tumble dryer. Underfloor heating in dining area.

Bedroom One - 2.8m x 3.2m (9'1" x 10'4") Carpet. Bay window.

Ensuite - 0.9m x 3.1m (2'9" x 10'1") Laminate flooring. Walk in shower, pedestal sink, toilet. Storage cabinet. Extractor fan.


Bedroom Two - 3.1m x 3.1m (10'1" x 10'1") Carpet. Window to front.

Bathroom - 2.7m x 2.2m (8'8" x 7'2") Laminate flooring. four-piece suite. Light tunnel. Airing cupboard housing combi boiler.

Garden Office/Gym - 3m x 2.4m (9'8" x 7'8") Fully insulated. Power and light.

Outside - the front of the property is partially fenced; a dropped kerb leads to a gravelled driveway allowing for parking for multiple vehicles. The rear garden is mostly laid to lawn with a patio area, gravelled side access leading to driveway.
