Open to utility area Hardwood worktop. Worktop lights. Plumbing for washing machine and space for tumble dryer. Tiled floor. Coving to ceiling with access to loft space

Rear Lobby - 3.6m x 1.4m (12'0" x 4'8") Half glazed door to side. Tiled floor. Coving to ceiling. Doors to Family room and Shower room

Shower Room - 2.9m x 2.5m (9'5" x 8'2")
Fitted with a three-piece suite comprising of recessed Walk in shower area, Wash hand basin and low level WC. Hard wood double glazed window to side. Tiled floor. Extractor. Under floor heating. Coving to ceiling with inset spotlights.
