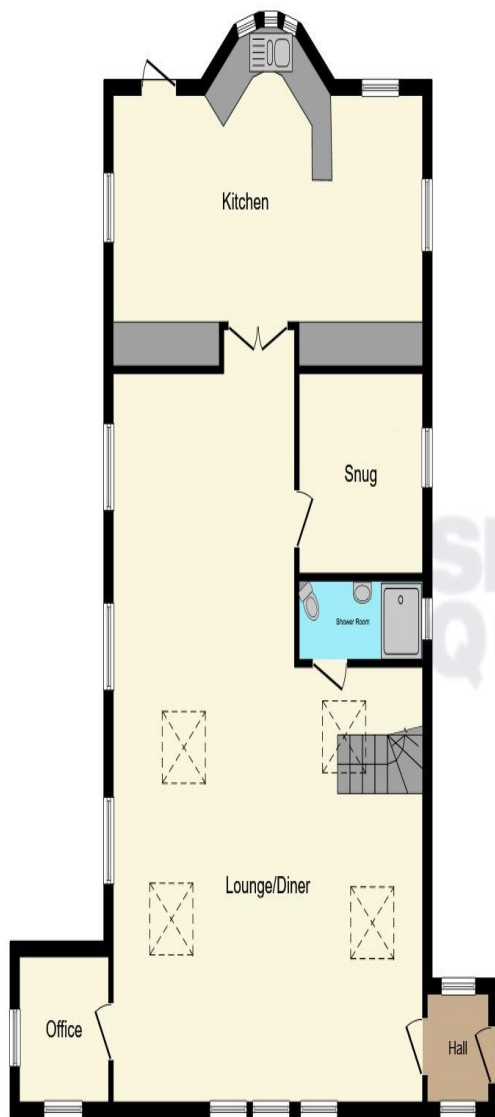

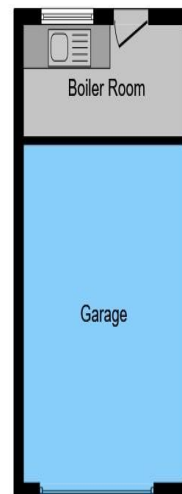




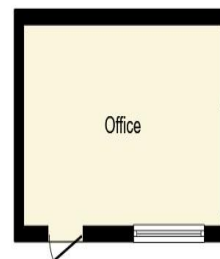
Ground Floor
