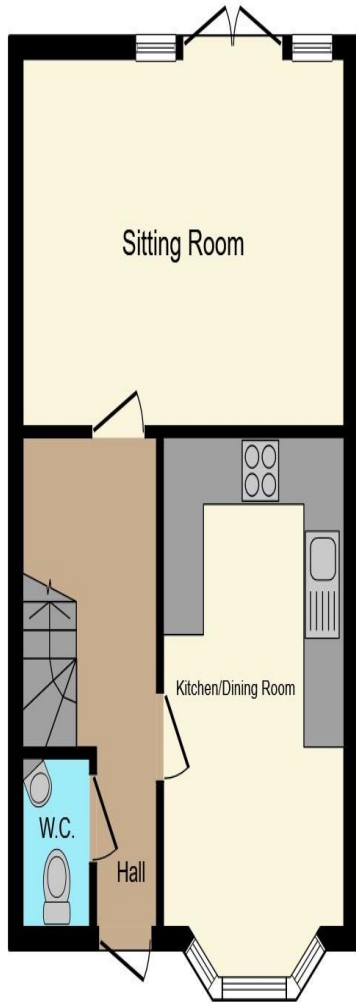

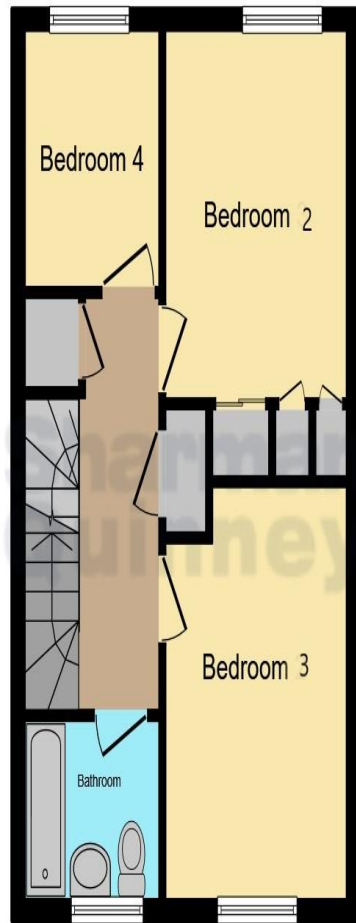

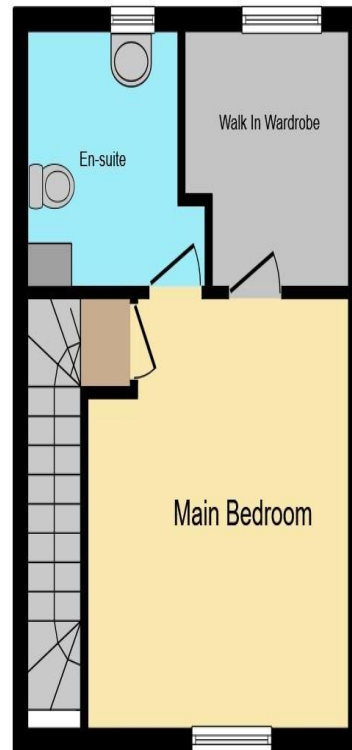




Ground Floor
