Kitchen/breakfast room 5.08m x 3.18m (16'8" x 10'5")

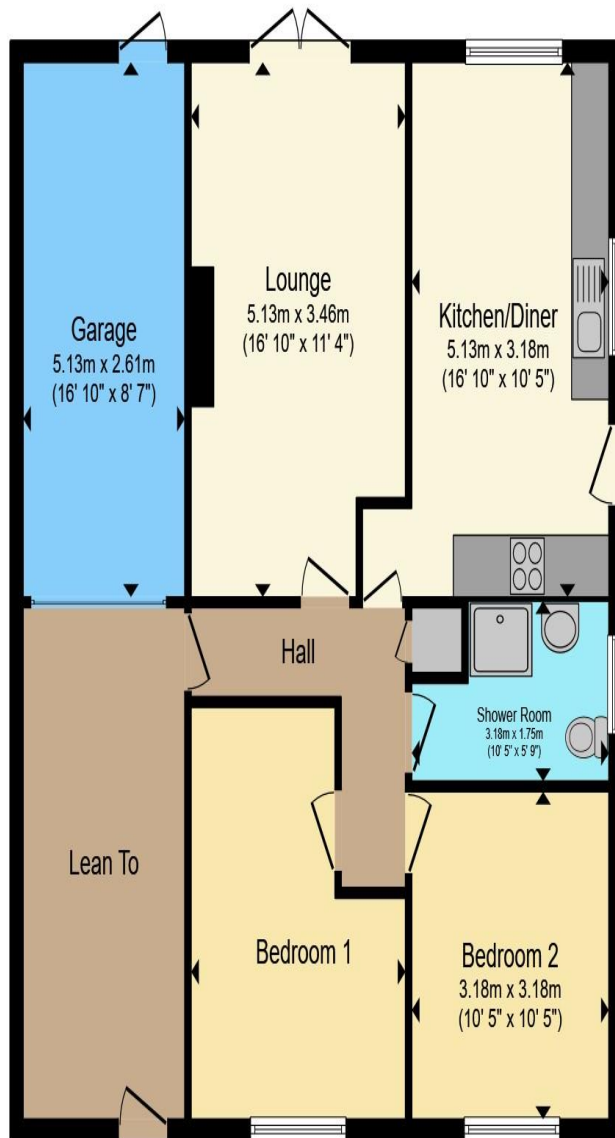
