A lovely two bedroom first floor apartment set back from the main road for over 55s located in Rose Court retirement complex, originally built by McCarthy and Stone, situated close to the village centre. Briefly comprising lounge/dining room, kitchen, two bedrooms and shower room. In addition, there are lovely communal areas to include good size lounge, communal gardens, laundry, parking, on-site manager and lift to the first floor. NO CHAIN

Via front door into entrance hallway.

## **Entrance Hallway**

Having three cupboards for storage.

#### Lounge/Dining room

25' 1" Maximum x 14' 10" Maximum ( 7.65m Maximum x 4.52m Maximum )

Two windows to the side and front, feature fireplace electric fire fitted, two thermostatic controlled electric radiators.

### Kitchen

7' 4" x 6' 9" ( 2.24m x 2.06m )

Fitted with a range of base and wall mounted units with complementary work surfaces, sink and drainer unit with mixer tap, appliances to include oven and fridge freezer.

Having fitted wardrobes providing hanging and shelving space, electric storage heater, window to the front.

#### **Bedroom Two**

13' 1" Maximum x 9' 8" ( 3.99m Maximum x 2.95m )

Having fitted wardrobes, provision hanging and shelving space, electric storage heaters, window to the front.

Fitted with a sweet comprising of low-level WC, wash hand basin with mixer tap, shower cubicle with electric shower fitted, extractor fan.
