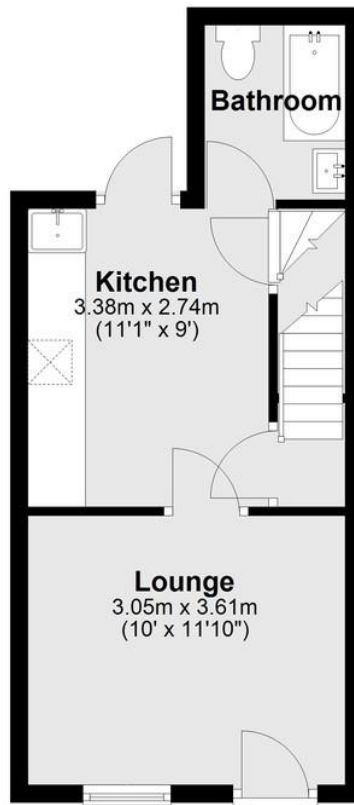
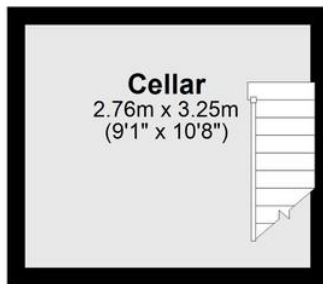


Ground Floor

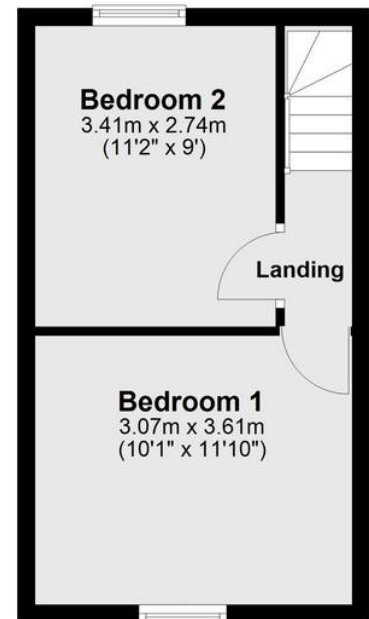
Basement
