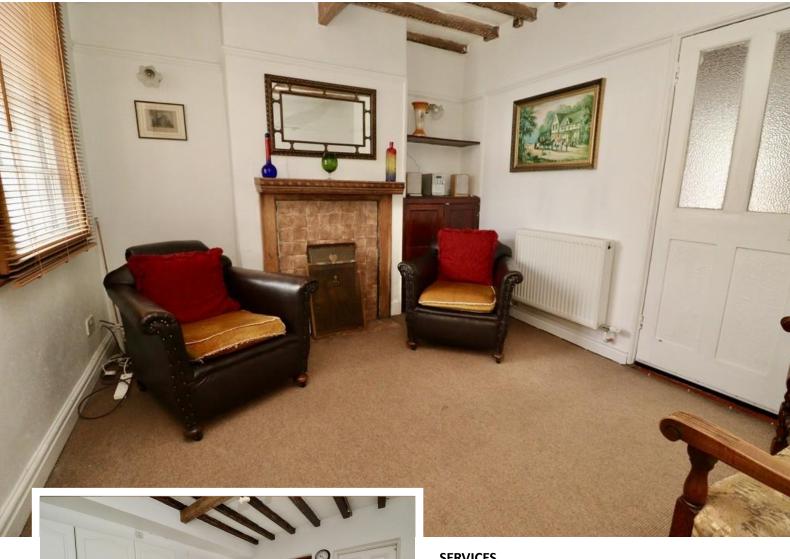

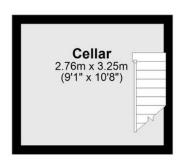

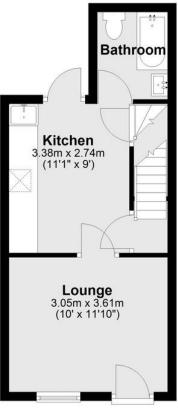


Ground Floor

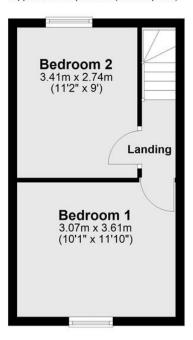
