

The village features local shops, a Coop, primary and secondary schooling, takeaways, hairdressers, a church and The Waggon and Horses public house. The village has a historic centre with many beautiful stone buildings. Branston is well served by the new Eastem Bypass providing easy access to the North of Lincoln and beyond and also has a direct bus route into Lincoln City Centre.

11' 8" x 9' 11" (3.56m x 3.04m), with double glazed window to the rear aspect, double wardrobe and radiator.




