Set in the highly regarded Second Drift, Wothorpe sit's this SIX BEDROOM period home requiring modernisation throughout and offering scope for expansion (STNPP). The property has been in the current family for some 60 years and ready to be enjoyed by a new family. The accommodation is arranged over three floors boasting, separate reception room, a breakfast kitchen with utility room, ground floor WC, four bedrooms & a bathroom to the first floor and two further bedrooms to the second. There is a private rear garden and stunning views to the front - CHAIN FREE!

On entering the home, you'll be greeted by the recess storm porch leading into the hallway with stairs to the first floor, useful storage cupboards and doors to reception rooms and kitchen. The living room is set to the front of the property with a bay window and feature fireplace. The dining room is set to the rear overlooking the gardens and has fitted double doors leading out to the side patio area. The kitchen is large enough to accommodate a table and chairs but offers scope to be extended to the side. From here leads on to the utility room with further access to the garden and a door to the around floor WC. To the first floor there are four bedrooms, a bathroom and concealed staircase rising to the second floor where there are two further bedrooms.

Outside, the property has a private frontage with inset shrubs and gravelling with a pathway leading to the front door and a shared passage with the neighbouring property which leads to a second access in to the kitchen. The rear garden provides a terraced seating area meeting a mature garden with lawn, inset shrub and a centralised pathway leading to gated rear access. The oil tank fuelling the oil fired central heating system is also housed in the rear garden.




