The commercial unit is tenanted with a 7 year lease originally granted from 8th February 2016 so the tenant is currently overholding with a passing rental income of £9,600.00 per annum. The apartment is being sold with vacant possession upon completion.

Presented to a high standard, the property still offers scope for further reshaping to suit specific requirements, making either the ideal investment purchase or the opportunity to purchase a home and generate income from the space below. The vendor has advised that there is a public car park within a very short distance, where you can obtain an annual permit for parking.

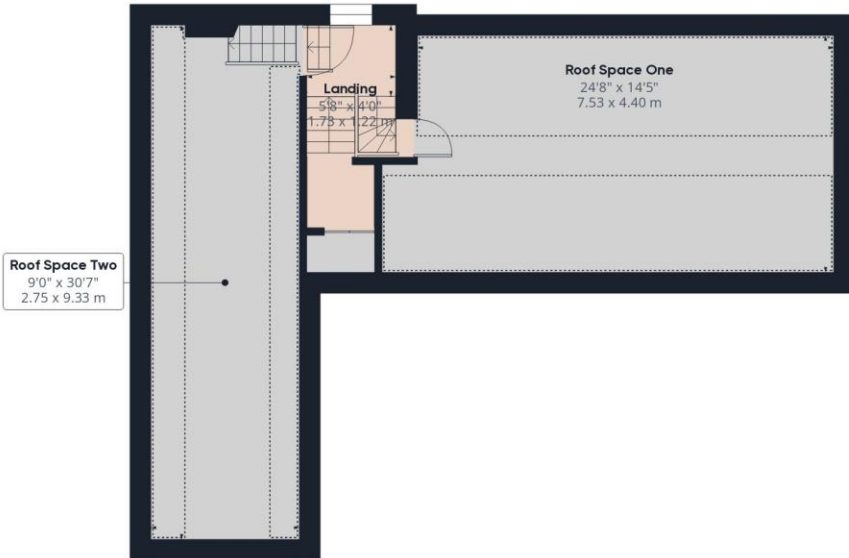
