#### LOCATION

The subject property is accessed via a private driveway on the north western side of Olton Road in the Shirley district of Solihull. The immediate surrounding area comprises of predominantly residential use with a number of commercial uses including retail and office situated on the nearby Stratford Road.

## DESCRIPTION

The property comprises a self-contained yard suitable for the purposes of storage and benefits from a gated entrance via a driveway from Olton Road in the Shirley district of Birmingham. The site currently comprises a mix of natural and tarmacadam surface covering with perimeter fencing and extends to approximately 0.3 acres.
