LOCATION

The property is located on Drayton Manor Business Park which is accessed off the A4091 Coleshill Road, Tamworth, to the south of Fazeley. To the north is the A5 trunk road which provides dual carriageway access to the M6 Toll J4 and M42 J10. To the south via the A4091 is the Belfry Golf Course and M42 J9 providing access to Birmingham City Centre, International Airport and NEC.

DESCRIPTION

Office 1 provides a self-contained office incorporating a passenger lift, welfare and kitchen provisions. Internally, the layout is a combination of partitioned private offices, meeting rooms and open plan areas that benefit from good levels of natural light.
