#### PLEASE NOTE Holding Deposit

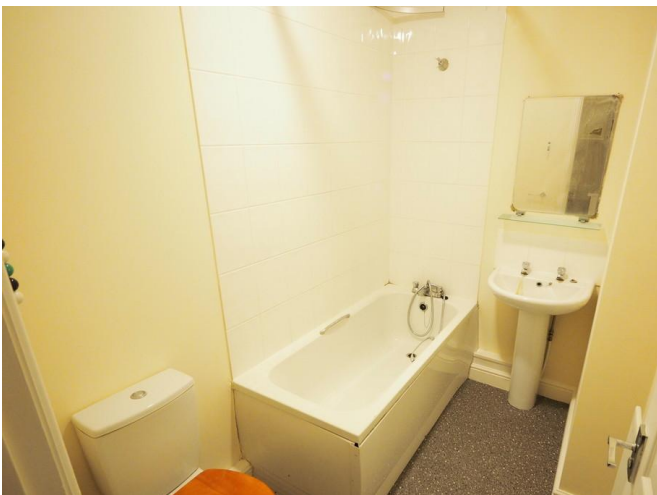

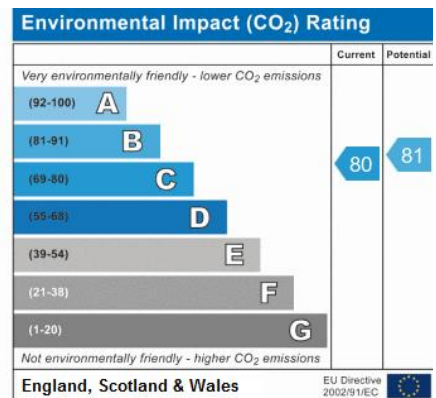
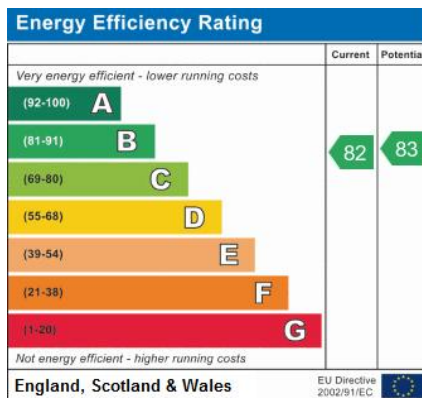
#### Reference Checks and Credit Worthiness

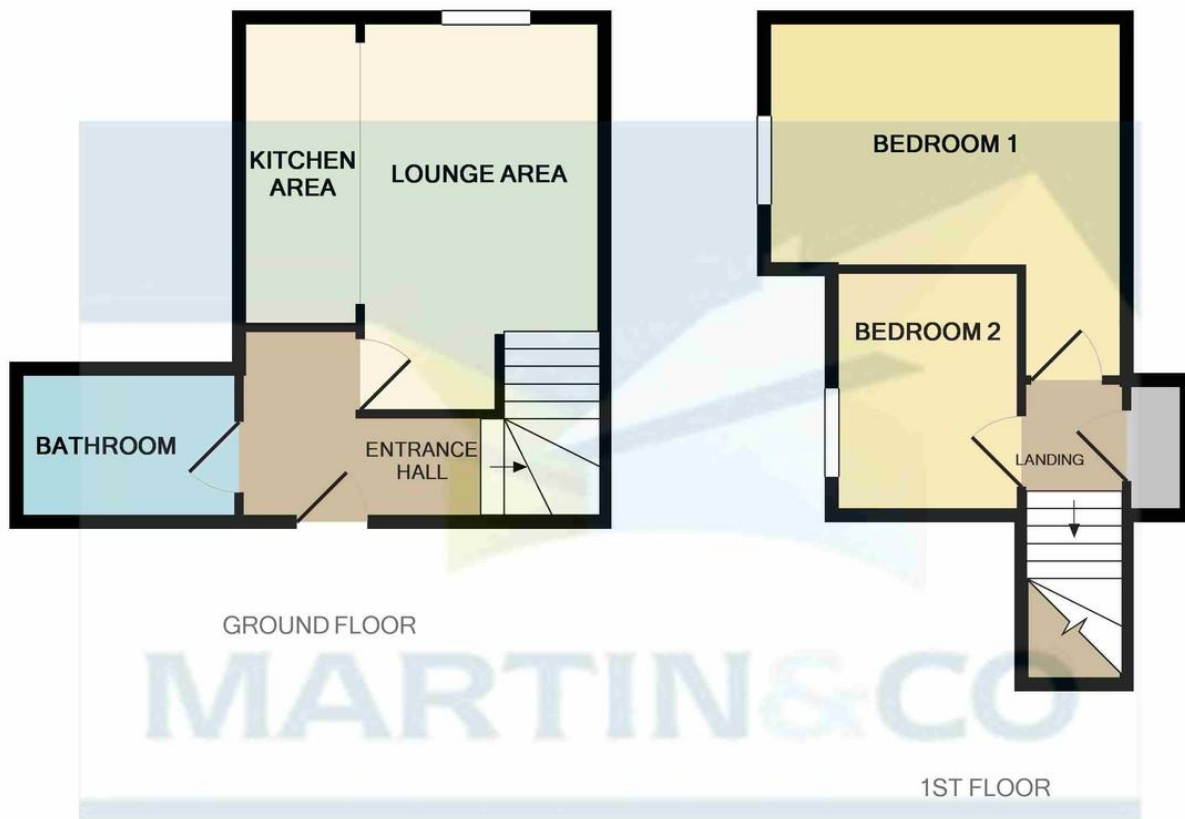
#### Documentation that may be required
