#### GROUND FLOOR

#### Living Room

#### 10°11" x 14°0" into bay (3.34m x 4.27m into bay)

The living room has a UPVC double-glazed bay window to the front elevation, fitted cupboards, carpeted flooring, a fireplace, coving to the ceiling, a radiator, an aerial point, and a single UPVC door providing access into the accommodation.

#### Dining Room

II\*6" × I0\*II" (3.52m × 3.34m)

The dining room has a UPVC double-glazed window to the rear elevation, wood-effect flooring, a radiator, a fireplace, an in-built cupboard, and an aerial point.
