\*\*£150,000 for a 50% share\*\* A brand new three bedroom semi detached house, located only a 15 minute walk from Skipton High Street, available for sale by way of a shared ownership scheme from North Yorkshire Council. The price quoted is on the basis of a 50% share of the market value being purchased, with an initial rent payable at 2.75% of the unsold equity.

#### **DESCRIPTION**

Hawbank Field comprises a new residential development constructed by Stonebridge Homes. Plot 36 is offered by way of a shared ownership scheme from North Yorkshire Council - the purchaser will initially buy between 25% and 75% of the property, which will be determined by their financial advisor.

Plot 36 comprises an entrance at ground floor level with corridor leading to a kitchen diner and WC. Staircase leads up to the first floor where there is a well proportioned living room, house bathroom and master bedroom. A further staircase leads up to the second floor with a spacious landing and two further double bedrooms. Externally there is an enclosed lawned garden to the rear and two car parking spaces to the front.

#### **ENTRANCE HALL**

Accessed from the front door with doors leading into the kitchen diner and WC. Stairs lead up to the first floor landing.

#### KITCHEN DINER

4.96m x 2.93m (16'3" x 9'7")

Comprising a range of base and wall units with contrasting work surfaces and stainless steel sink with mixer tap. Four ring hob with extractor hood over and under counter oven. Under counter space and plumbing for a washing machine and space for a fridge freezer.

#### WC

With WC and wash hand basin

#### FIRST FLOOR LANDING

With doors leading to the lounge, house bathroom and the master bedroom. Stairs lead up to the second floor landing.

#### LOUNGE

5.06m x 3.40m (max) (16'7" x 11'1" (max)) Double doors lead out to the rear garden

#### **HOUSE BATHROOM**

Comprising a white wash hand basin, WC and panel bath with shower over.

#### **MASTER BEDROOM**

 $5.06m \times 3.27m \text{ (max) } (16'7" \times 10'8" \text{ (max))}$  Double bedroom with two windows overlooking the front of the property.

#### SECOND FLOOR LANDING

Spacious landing with cupboard and doors leading into two bedrooms.

## **DOUBLE BEDROOM 2**

4.03m x 2.55m (13'2" x 8'4")

Double bedroom with window overlooking the rear garden.

#### **DOUBLE BEDROOM 3**

3.40m x 2.42m (11'1" x 7'11")

Double bedroom with window overlooking the rear garden.

#### **OUTSIDE**

To the front of the property there are two car parking spaces. To the rear is an enclosed lawned garden.

#### **COUNCIL TAX BAND**

To be assessed.

#### TENURE AND SHARED OWNERSHIP

This property will be sold on a leasehold basis on a new 125 year lease.

The property is available by way of shared ownership and is only available to first time buyers, or people who used to own a home and cannot afford to buy a new one, with a combined income of less than £80,000 per annum. Priority will be given to serving military personnel and former members of the British Armed Forces discharged within the last two years. The price quoted is on the basis of a 50% share of the market value being purchased, with an initial rent payable at 2.75% of the unsold equity (reviewed annually in line with inflation).

In order to proceed with a purchase any applicant must first obtain proof from a suitable mortgage or financial advisor that they meet Homes England's eligibility criteria, including affordability criteria.

Please note that applicants with a local connection to Skipton will be given priority for the purchase of the homes in the first instance. Local connection is defined as:

Having resided in the area for 3 years out of the past 5; or

Having previously lived in the area for 20 years (or half that persons lifetime, minimum of 10 years); or Having Immediate family who have lived in the area for five years (parents, siblings or children); or Employed in the area with a company which has been established for 3 years and are employed for a minimum of 16 hours per week for 12 months


#### **Anti Money Laundering Regulations**

GROUND FLOOR 1ST FLOOR 2ND FLOOR


