SITUATION

Gillingham is an expanding and popular town in North Dorset with the main line railway link to London Waterloo being a particular benefit.

PROPERTY

This site extends to circa 0.7 acres and was formerly used as a yard and buildings for a well known local company dealing in the wholesaling of sand and gravels. There is a Victorian 2 storey brick building which is to be converted into a pair of dwellings and a modern industrial building that is to be demolished and the whole site redeveloped. The modern industrial building will be removed by the seller prior to a sale being completed.

PLANNING

Full planning approval has been granted by Dorset Council for a total of 17 dwellings (including the two conversions) together with some commercial space , under planning reference P/FUL/2022/02964 dated 29 March 2023.The proposed scheme of development comprises eight 3 bedroom town houses, five 2 bedroom houses, two 2 bedroom conversions and two duplex apartments. A ground floor commercial space currently shown as two units is also approved. As nutrient neutrality is not relevant to the scheme, the development can proceed immediately subject to various conditions being discharged. There are no S 106 liabilities and no affordable housing required. Community Infrastructure Levy is applicable.
