The Humber Bridge and Humber International Airport are located approximately 14 miles to the south west. North East Lincolnshire has a residential population approaching 150,000 although benefiting from a much larger surrounding catchment area.

The Immingham Container Terminal, which operates 24/7, is a regional centre for deep sea container imports, enabling customers to transip deep sea containers direct to the Port of Immingham on regular short-sea feeder vessels.
